I also understand that there will be no refund of tuition paid in July and August for students who are enrolled but are withdrawn prior to the beginning of school. A two month early withdraw penalty will be assessed for students who withdraw prior to the end of the school year unless there is a documented job transfer outside the area. These assessments are made in consideration of the obligations that the school has taken on in my behalf upon enrollment of my child(ren).
